to the Agreement between the Government of Mongolia and the Government of the Republic of Poland and on extending a tied aid credit, done at Ulaanbaatar on May 9, 2017, amended by Annex done at Ulaanbaatar on July 9, 2019 and Annex done at Ulaanbaatar on March 11, 2021

The Government of Mongolia and the Government of the Republic of Poland, henceforth called the "Contracting Parties", with a view to continue the constructive economic co-operation between Mongolia and the Republic of Poland, in accordance with Article 13 of the Agreement between the Government of Mongolia and the Government of the Republic of Poland on extending a tied aid credit, done at Ulaanbaatar on May 9, 2017, amended by Annex done at Ulaanbaatar on July 9, 2019 and Annex done at Ulaanbaatar on March 11, 2021, have agreed as follows:

Article 1

The Agreement between the Government of Mongolia and the Government of the Republic of Poland extending a tied aid credit, done at Ulaanbaatar on May 9, 2017, amended by Annex done at Ulaanbaatar on July 9, 2019 and Annex done at Ulaanbaatar on March 11, 2021, shall be amended as follows:

- 1) Article 3 paragraph 2 shall be amended to read: "2. The contracts referred to in Article 1 shall be concluded by entrepreneurs having their seats in the Republic of Poland, henceforth called "Polish entrepreneurs", and the importers from Mongolia not later than on December 31, 2026."
- 2) Article 8 shall be amended to read:

"Article 8

Payments to the Polish entrepreneurs resulting from the contracts realised under this Agreement shall be made under the stipulations of the Agreement until the date of the execution of these contracts, according to the terms of the relevant contracts, but for no longer than 8 (eight) years from the date the contract enters into force.";

- 3) the enclosure which specifies the projects to be financed under the Credit shall be amended, in wording of the enclosure to this Annex.

Article 2

This Annex shall be subject to approval in accordance with internal law of each of the Contracting Parties, which shall be confirmed by exchange of notes. This Annex shall come into force on the date of the receipt of the later note. This Annex remains valid until all obligations of both Contracting Parties arising from the Agreement between the Government of Mongolia and the Government of the the Republic of Poland on extending a tied aid credit, done at Ulaanbaatar on May 9, 2017, amended by Annex done at Ulaanbaatar on July 9, 2019, Annex done at Ulaanbaatar on March 11, 2021, and this Annex are fulfilled.

Done at on in two originals, each in the Mongolian, Polish, and English languages, all texts being equally authentic. In case of any divergences of interpretation of the Annex, the English text shall prevail.
